Gandhinagar Municipal Corporation has established Vermi Compost plants, where it produces compost from the wet waste generated in the city. The compost produced by GMC at all three plants is brought to a single location for its sale. GMC intends to obtain an ISO 14000 series Environmental Management System Certificate for these processing plants. Interest agencies having valid National Accreditation Board for Certification Bodies (NABCB) accreditation are invited to submit the quotations in sealed envelope for issuance of the ISO 14001:2015 certification.

Terms & Conditions

- "Annexure-1 General Information" is attached with this notice describing details such as scope of work, number of employees involved, process adopted, etc. Bidders are suggested to review the same before submitting its quote
- 2. Bidders are required to submit details of the organization as per "Annexure 2: Details of Organisation" along with the quotations.
- 3. Quotes shall be submitted on the letter head of the bidder as per the format shared provided in **Annexure 3: Financial Offer**.
- 4. Price to be quoted shall be inclusive of all applicable taxes except GST.
- 5. The selection of the bidder shall be based on Least Cost Selection method. The bidder who submits the lowest amount will be considered as preferred bidder (L1).
- 6. The quotation is to be submitted in sealed envelope via Registered Post/ Speed post/ In-Person/ Courier, addressed to Deputy Municipal Commissioner, GMC and labelled as "Quotation for ISO 14001:2015 certification"
- 7. Bidder is required to submit the valid National Accreditation Board for Certification Bodies (NABCB) accreditation certificate along with bid.
- 8. The last date for submission of quotation shall be 05/05/2025 up to 18:00 hours.
- 9. In case of any dispute or queries regarding performance, the decision of the Municipal Commissioner, Gandhinagar Municipal Corporation will be final and binding.

Annexure-1- General Information

- **1. Type of Certification:** New Certification, Environmental Management System Certificate, ISO 14001:2015
- 2. Background: Gandhinagar Municipal Corporation serves as an Urban Local Body for Gandhinagar; it is established under the Gujarat Provincial Municipal Corporation Act of 1949. GMC provides various services to the citizens of Gandhinagar including solid waste management, for which GMC has established several wet waste processing facilities. At these facilities waste is processed and converted into compost, which is further sold and self-utilized.

3. Scope of Work for Certification:

Gandhinagar has established three Vermi Composting Plants in the city. The key process activities that are adopted in the plants are mentioned below,

- 1. **Receipt of Materials at Processing Facility:** Segregated waste, cattle dung, and dry leaves are received at the processing facility.
- 2. **Sorting of Segregated Waste:** The segregated waste is further sorted to remove unwanted materials such as plastic, paper, etc.
- 3. Shredding of Wet Waste: The segregated wet waste undergoes shredding.
- 4. **Mixing and Preparation of Windrows:** The shredded waste is mixed with cattle dung and dry leaves, and windrows are prepared for pre-treatment.
- **5. Preparation of Vermi beds and introduction of worms:** After preparation of Windrows, worms are introduced in the windrow beds for further processing in two of the plants. While in the third plant, the process slightly varies where the windrow bed after its initial curing time is entirely transferred to a separate Vermi pit and worms are introduced for processing of the waste.
- **6. Moisture control:** Water is sprinkled to retain moisture in the bed through manual and mechanical means.
- 7. **Sieving:** The processed output from the vermi-beds is sieved.
- 8. **Packaging and Storage for Sale:** Once sieved, the compost is packaged and stored for sale.

The Municipal Corporation oversees the regular operation and maintenance of these facilities, ensuring efficient compost production and sale. The scope of certification shall be limited to the activities within the processing facility starting from the receipt of waste up to sale/self-utilization of processed output.
